The Bureau of Planning & Licensing is in receipt of an administrative action to the Cumberland County District Solid Waste Management Plan (“County Plan”), dated October 14, 2021. This amendment to the County Plan proposes County Plan inclusion of The Authority’s designated truck routes for solid waste vehicles entering and exiting the facility, located on Block 76, Lot 14 in Deerfield Township.

Apart from the regular or routine service operations, every solid waste vehicle for transportation of solid waste shall use the designated routes for access to and from the Cumberland County Solid Waste Facility. The designated routes are as follows: State Route 47, State Route 49, State Route 55, Landis Avenue (State Route 56), State Route 77, Sherman Avenue (County Route 552), County Route 553, Hogbin Road (County Route 625), Nabb Avenue (County Route 634), Jesse Bridge Road (County Route 636), Buckshutem Road (County Route 670).

- From Millville, West on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636) or West on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).

- From Bridgeton East on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636) or East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636) or East on Landis Avenue (State Route 56), South on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).

- From Maurice River Township, North on State Route 47, West on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636) or North on State Route 55, West on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).
- From Downe Township, North on Hogbin Road (County Route 625), West on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).
- From Lawrence Township, North on Hogbin Road (County Route 625), West on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).
- From Fairfield Township, North on County Route 553, East on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).



- From Greenwich Township, East on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).
- From Hopewell Township, East on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).
- From Shiloh Borough, East on State Route 49, North on Nabb Avenue (County Route 634), East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).
- From Upper Deerfield, South on State Route 77, South on County Route 553, East on Landis Avenue (State Route 56), South on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636) or South on County Route 553, East on Sherman Avenue (County Route 552), North on Jesse Bridge Road (County Route 636) till you reach the Cumberland County Solid Waste Facility located at 169 Jesse Bridge Road (County Route 636).

Pursuant to N.J.A.C. 7:26-6.11(b) 2, the inclusion of designated truck routes to or from solid waste facilities can be accomplished via an administrative action. Therefore, County Plan inclusion of designated truck routes for The Authority, is hereby approved as an administrative action pursuant to N.J.A.C. 7:26-6.11(f).
