### What's Happening at the Solid Waste Complex?

#### June 11 Household Hazardous Waste and Document Shredding Results

The Authority hosted its second Household Hazardous Waste and Document Shredding event of 2022 on Saturday, June 11. In total, 498 Cumberland County residents attended the event, resulting in the proper disposal of 4.515 tons (9,030 pounds) of hazardous waste. In addition, 766 gallons of used oil and 48 gallons of antifreeze were collected. Furthermore, 5.63 tons (11,260 pounds) of paper were shredded and recycled during the June event. A total of 3.119 tons (6,238 pounds) of electronic waste were collected, sorted, stacked, and shipped out to be recycled. The final Household Hazardous Waste and Document Shredding event of 2022 will take place on Saturday, September 17 at the Solid Waste Complex.

#### Jesse Bridge Construction Complete

Jesse Bridge construction has been completed. Starting January 24, 2022, Jesse Bridge Road, from Landis Avenue to Lebanon Road, was closed for bridge renovations. Jesse Bridge is now open and alternate routes to the Solid Waste Complex are no longer required.
