What's New at The Authority?

Food Specialization Center

The Food Specialization Center received the Certificate of Occupancy for the overall 33,000 sq ft +/- facility from the City of Bridgeton on July 20. With the completion of the SIMULATE and CHANK's expansion tenant fit outs, the building will be 100% occupied.

SIMULATE received the Certificate of Occupancy for the 7,200 sq ft +/- tenant space from the City of Bridgeton on July 20. SIMULATE is 100% operational. With the food production success of their existing tenant space, SIMULATE has requested to expand into the Suite "D" tenant space (3,700 sq ft +/-). This space will house additional food production equipment related to their cooking process. This process will also require the construction of a 350 sq ft +/- building addition, to house a thermal heater for FRYER operations, to be located on the eastern side of the building, in an area previously approved for building expansion.

With the food production success of their existing tenant space, CHANK's has requested to expand their space adding additional tenant space (1,237 sq ft +/-). This space will house additional food production equipment related to their production process as well as storage and office areas.

Business Grant Program

As part of the county's Covid recovery plan, a financial assistance program for small business economic development was established last fall. The Authority has assisted about 71 businesses, representing \$703,000 dollars of assistance. The funds have been used for new equipment, payroll, inventory, and general operating expenses and have been distributed countywide. The businesses assisted have less than 10 full time employees and must have been in business prior to December 2019.

The Authority managed the renovation of the historic East Point Lighthouse.

Through a partnership with Maurice River Historical Society and the County Freeholder Board, The Authority was able to complete \$850,000 in exterior renovations, funded by grants from the NJ Historic Trust Grant and the Federal Highway Administration. Listed on the National Registry of Historic Places, the lighthouse was constructed in 1849 along the Maurice River, on the north side of the Delaware Bay. The project was completed in 2017.
