What's New at The Authority?

Millville Library Update

Construction of the Phase 1 Addition at the Millville Public Library is progressing toward a late September completion. Ceiling grids, lights, and drywall have been installed. The new heating and air conditioning equipment has been started up and programmed. Present work includes interior painting and exterior sitework.



Rowan Medicine Building Update

Progress continues on the Rowan Medicine Building. Exterior masonry, interior drywall, and windows are complete. Interior electrical work continues, as well as data cabling. Next up, is the exterior metal panels to finish out the exterior of the building finish. Site work is expected to begin late August to early September.



Salem County Courthouse

The Salem County Criminal Courthouse Addition Building B is 95 percent complete, with an expected occupancy by the beginning of August. Finishes are 100 percent complete on Floors 2 and 3 with efforts now concentrating on Floor 1. System's commissioning is taking place including programming the Court Recording system. Computer NETWORKS are running approaching final checkout and final Professional Consultants' "punch-lists" have started. Renovations to Building A will begin in the near future, along with the replacement of the decorative columns and eaves on Market Street.



Bridgeton Fire Station

The new Bridgeton Fire Station includes a complete renovation of the existing historic former City Hall building and includes a 13,500 square foot single story addition with five apparatus bays. The Emergency Services will also occupy the facility. The facility will include modern facilities for staff, meetings, living quarters, conference rooms, training rooms, a kitchen, and an exercise area. The project is expected to be complete early 2025.



Broad Street School HVAC Upgrades and Building Renovations

Phase 1 of the Broad Street School HVAC upgrades is progressing daily. Thermal piping and their subcontractors have been hard at work completing the Phase I demolition. Locker room and storage renovations are underway. Masons, plumbers, electricians, flooring, and ceiling subcontractors will be hard at work throughout August.
